The Madras High Court on Friday issued a warrant for the arrest of senior Congress leader and former Union Minister Murlidhar Deora in the Godhra Train Burning case and ordered that he be sent to trial soon. Failing to get the government nod for granting bail, Mr. Deora had moved the high court seeking anticipatory bail while out on bail in a 2002 hit-and-run case. Mr. Deora, 74, who is in Pune, and not represented by his counsel in the case, was not present in the court and the presiding officer sent his letter and the application by videolink to him. The court passed the order under the 6A and 6AA. The 6A order permits the lodging of the application for the arrest of Mr. Deora even without his presence in the court and fixing of the time for the commencement of the trial. The 6AA, which is designed for expediting the trial when the accused is not present, permits postponing the trial till the next day if he is out on bail. In the 2002 hit-and-run case, Mr. Deora, a former union minister, was charged for leaving the spot and not stopping to see what had happened, after he hit a woman, who died. The sessions court had granted bail to Mr. Deora in the 2002 case in 2007. The trial was pending in the sessions court till 2014 when it was transferred to the special court. Mr. Deora has claimed that his letter had been handed over to the sessions court in 2014 and he had lost it. An FIR was lodged against Mr. Deora after one Sharat Sharma, who is suspected to have been the driver of Mr. Deora's car in the 2002 case, was identified. Mr. Sharma is said to have given contradictory evidence in the Godhra case. Mr. Deora has been charged along with five others for the arson and rioting in which 59 people were burnt to death and more than 200 others were injured when more than a thousand kar sevaks were returning from Ayodhya to Godhra on February 27, 2002.
